Anti-Corruption Policy

Expected to update: [1st Feb. 2024]

JCR Pharmaceuticals Co., Ltd. and its subsidiaries and associates (hereinafter collectively, the "JCR Group" or "we") conducts to prevent corruption in all its forms and to promote its compliance globally.

1. Compliance with laws and regulations

The JCR Group strictly adheres to all applicable anti-corruption laws and regulations in all countries in which it operates and acts fairly and ethically in accordance with its internal rules and regulations.

2. Scope

This Policy applies to all directors, officers, and employees of the JCR Group, including external contractors working on behalf of the JCR Group (the "JCR Group Employees").

3. Definitions

Public Official means any natural person who: holds, whether elected or appointed, a legislative, administrative, or judicial position of any kind in any country, state, or territory, regardless of his or her position; performs public functions in any branch, agency or instrumentality of the national, federal or municipal government of any country, state or territory; performs public functions for any public agency or public enterprise of any country, state or territory; or is considered a public official or quasi-official in accordance with applicable laws.

4. Bribery

The JCR Group must not offer, propose, promise or solicit, directly or indirectly, entertainment, gifts, money or any other bribes to any Public Official in Japan or abroad, in order to obtain or retain business benefits, to avoid disadvantages to itself or the JCR Group, or in return for such actions.

The JCR Group must not offer, promise, solicit or accept, directly or indirectly, any entertainment, gifts, money, or other bribes to its business partners, either in Japan or abroad, in an improper manner. In addition, we recognize that making payments to Public Official to facilitate or expedite procedures with the government is basically considered a type of bribe.

5. Governance

The JCR Group establishes a management system to promote the prevention of corrupt practices, as well as the Internal Procedures for the Prevention of Corrupt Behavior based on this Policy.

6. Assessment and action

The JCR Group identifies and assesses, as required and as appropriate, the risks of corrupt practices and takes necessary measures to prevent corrupt practices.

Before entering a transaction with a new third party, the JCR Group examines and evaluates, in consultation with the relevant departments, as necessary, for the purpose of preventing corrupt practices by the third party.

7. Violation

If any JCR Group Employees violates the Anti-Corruption Laws, this Policy, or the Internal Procedures for the Prevention of Corrupt Behavior, he/she will be subject to disciplinary action.

8. Continuous Improvement

The JCR Group continuously inspects, reviews, and makes improvements to the efforts described in items 1 to 7 above.
